Good day,

Thank you for allowing us to reach out regarding the concerns of our excessive water usage at our commercial building. We would like to appeal our position in the matter as we do not feel the charges are fair to us based on our limited access to the property.

Upon receipt of the first large bill, we investigated all the units and found no leaks or traces of running appliances. That being said, our thoughts were one of our tenants that was retiring may have been cleaning their equipment in order to liquidate asset's.

When I contacted the Kawartha lakes upon receipt of the second bill. I left a message and had not received a response. Covid shutdowns happened shortly after, and we received a call from one of our other tenants saying they contracted a plumber to change the toilet in their unit. It had a faulty valve. Turns out it was the culprit after all.

The issue that arises is they use the unit for storage as they are into landscaping and property maintenance. The toilet ran on for long periods after a flush which during the winter months we were unable to distinguish because when we looked at it, it probably hadn't been used for a period of time and eventually closed.

After requesting an exemption, we were told that the next steps would be to appeal in front of council in regards to softening the burden of costs.
