1. **MINUTES** - July 5, 1988

2. **DELEGATIONS AND DEPUTATIONS**

A. Proposed Road Allowance closings

(i) Part of Road Allowance between Lots 72 and 73 Front Range

Reeve Watson asked if anyone had any objections to this proposed road closing.

John Davidson advised Council that he objected to the road closing. He owns 4 acres of land (back lot) near the subject land. He advised that he would have no access to Shadow Lake if he sold his waterfront lot.

Doran Lee advised Council that the closing of the road allowance would cut off his access to Shadow Lake. His farm runs parallel to the road allowance in question.

Gordon Wray the previous owner of the lot adjacent to the subject road allowance advised Council that he was the joint applicant along with Keith Baldry, for the road allowance closing. The present access used by the public is over a private driveway. The subject road allowance is treed.

Mr. *Del Medico* the purchaser of the land from Mr. Wray advised that he would withdraw the application in light of the objections received.

(ii) Part of Road Allowance between Lots 15 and 16 Concession 4

No one appeared to speak in support or in objection to this proposed road closing.

B. Shirley Handley re: severance application File B-71/88

Robert Mason, agent for Mrs. Handley advised Council of their concerns with respect to the Ministry of the Environment comments with respect to the severance application. The Ministry advised that they have concerns with the development of the land for residential purposes subject of the application within 500 metres of the landfill site. Mr. Mason felt that this would devalue the property.

A request was made for the Township to contribute towards the construction of the concession booth which cost \$10,011.43 at the Recreation Park. The Association requested that the Township pay the electrical portion of the cost.

- B. R. DelMedico, K. Baldry re: proposed road allowance closing Part Lots 72, 73 Front Range

Messrs. Del Medico and Baldry requested Council to reconsider the matter of the proposed road allowance closing of part of Lots 72 and 73 Front Range. At the public meeting held August 2, 1988 objections over the closing were raised by John Davidson and Doran Lee. It was noted that Mr. Davidson already has deeded access to Shadow Lake. In Mr. Lee's case access to Shadow Lake was being used through Mr. DelMedico's property.

It was suggested that they obtain withdrawals of Messrs. Lee and Davidson's objections in order that Council may further consider the road closing.
