There is currently no operating funding in the budget for cultural organizations' staff and certain operating expenses. The City's Cultural Masterplan recommended the development of a municipal performance based grant program. Recommendations are targeted for later this year, and could inform future budgets (beginning in 2024). During the pandemic, pandemic recovery funding was offered to Arts and Cultural organizations through an application-based process for modest operating budget relief. Options for consideration: 1) Fund the Kawartha Lakes Museum and Archives, as requested, through an increase in the tax levy in 2023, for all or a portion of the requested funding. 2) Provide no additional funding in 2023, and wait until a decision on an annual grant funding program is made (and that funding program would structure eligible operating funding, including staff costs, for this and other organizations). 3) Fund a one-year "transitional" operating grant funding program for arts and culture organizations to apply to for staffing funding relief (with a capped fund limit for any individual organization to request). For 2023, funding was not committed to in the draft budget, so if council wishes to fund this year, options are: 1) increase the operating tax levy 2) Fund from the Em:Power (Pandemic Recovery) Reserve. Option 2 is recommended as it meets the goal of pandemic tourism recovery supports and programs.
