#### 1. Call to Order

#### 1.1 Call to Order

Deputy Clerk and Recording Secretary J. Watts called the meeting to order at 6:31 p.m. Drainage Board members Deputy Mayor T. Richardson, Councillors R. Ashmore and D. Joyce, and C. Clarke, R. MacEachern, J. Oriotis, D. Skrabek, A. Veale and T. Willcox were in attendance.

Director of Engineering and Corporate Assets J. Rojas and Manager of Engineering-Technical Services M. Farquhar were also in attendance.

### 1.2 Appointment of Chair and Vice-Chair

Deputy Clerk Watts welcomed the new members of the Board, and explained the roles of Chair and Vice-Chair, and the nomination process.

# 3. Meeting to Consider - Desroches Municipal Drain

#### 3.1 Presentation of Engineer's Report - Desroches Municipal Drain

Michael Gerrits, P. Eng., M. Gerrits Consulting Inc.

The Chair asked Drainage Engineer, Michael Gerrits, to present his Engineer's Report on the proposed Desroches Municipal Drain.

Mr. Gerrits provided a brief summary of his report prepared pursuant to Section 4 of the Drainage Act, RSO 1990, noting that this report was prepared at the request of a landowner (J. Desroches and Estate of Desroches) who filed an petition with the City Clerk's Office on November 10, 2020, following the recent installation of a tile system on the Desroches lands. He noted that the objective of this report is to ensure a sufficient outlet for the petitioning landowners lands. Other items from his report he highlighted included the following:

- Existing conditions, including existing drainage systems on the Little and Mark properties;
- Summary of three on-site meetings on August 18, 2021, April 19, 2021 and November 23, 2021;
- Design elements for the proposed drain;
- Cost estimates in the total amount of \$349,123.00;
- Summary of assessment allocations including allowances;
- Maintenance and construction specifications;
- Overview of the plan and profile of the design; and
- A summary of issues presented by four landowners being: D. Desroches,
   E. Picarelli, M. Whalen, and G. Little

Mr. Gerrits made himself available for any questions from the members of the Board and the public.

#### 3.2 Question and Answer Period

Members of the Drainage Board Members of the Public

The Chair permitted the Board Members to ask questions of the Engineer. M. Gerrits.

The Chair advised all in attendance today that they would each be given an opportunity to provide comments and questions to the Drainage Board, City Staff and the Engineer. The following members of the public presented the following themes in their questioning:

- G. Little presented questions regarding the loss of topsoil, and erosion on his property prior to the filing of the petition;
- B. Webster (who works the Orsite Development lands) presented concerns whether the proposal has been drained to a sufficient outlet, whether there is liability for the work done on the Desroches land by the tile drainage installer or the landowners, and how deep is the proposed drain going to be;
- L. Moss presented questions about individual and total assessments on the north side of Little Britain Road;
- M. Whalen presented concerns about the design of the drain with the
  potential for fast water making sharp turns around and directly in front of
  his properties, as opposed to crossing Little Britain road directly where the
  drain meets it;
- G. Mark presented concerns with the volume of water existing on his property, and the attempts that have been done to remedy the situation on the land including an existing tile, and excavation works; and
- J. Hughson inquired if the proposed drain only drains the Desroches lands or the whole area.

To each of the questions posed by the members of the public, the Chair permitted the Engineer M. Gerrits, or M. Farquhar to respond to the questions put forward by the members of the public. The Chair inquired if any other persons had any other final questions for the Engineer at this time. Members of the Board put forward final questions, and no other questions were presented by the members of the public.

3.3 Opportunity to Add or Withdraw Signatures to the Petition

Mr. Farquhar provided an overview of the option for adding or removing names from the petition, and the advantages and responsibilities of doing so. The Chair inquired if any persons in attendance at the meeting wish to add or remove their name to the petition. No persons present indicated that they wished to sign or remove their names from the original petition at this time.
