That Council authorize the option to renew the contract, after the initial term for an additional four (4) one (1) year terms, pending successful completion of the initial term and each subsequent renewal, budget approval, Consumer Price Index All Items excluding Energy – Ontario increase and mutual agreement;

That subject to the receipt of the required documents the Mayor and Clerk be authorized to execute the agreement; and

That the Procurement Division be authorized to issue a purchase order.

Background:

A request for quotation for street sweeping services was issued in accordance with the City's Purchasing Policy. The quotation closed on March 9, 2023 and was opened by Launa Macey, Supervisor of Procurement Services with the following results:

Submissions were checked for compliancy to the procurement document. References were checked and found to be satisfactory.

As per the Purchasing Policy, procurement awards for operation contracts with an aggregate value of \$100,000 or greater must be approved by Council if the recommendation encumbers future operating budgets.

Rationale:

Street sweeping services are an important factor into maintaining the City's municipal roadways after winter operations. Sweepers clean up left over debris such as sand and prevents salt from entering the storm systems. Further, it aids in maintaining a clean road surface for vehicular traffic.

Staff recommends that Cardan Road Cleaners Inc. be awarded Request for Quotation 2023-22-OQ Street Sweeping Services – Multi Year Contact for an initial one (1) year term at the estimated annual spend of \$203,000.00 plus HST.

The procurement documents allowed for hourly rates and the work is on an as required basis.
