That Request for Proposal 2023-02-CP Supply and Delivery of New Fire Rescue Pumper Trucks –Multi Year Contract be awarded to Camions Carl Thibault inc.;

That Request for Proposal 2023-03-CP Supply and Delivery of New Fire Rescue Tanker Trucks –Multi Year Contract be awarded to Camions Carl Thibault inc.;

That Council authorize the option to renew each of the contracts after the initial term for four (4) additional one (1) year periods, based upon annual Council budget approval, mutual agreement of the pricing and successful completion of the initial term and each term thereafter;

That the total deficit for these projects be funded by the Fire portion of the Fleet Reserve (1.32070) in the amount of \$781,530 and the remaining \$733,732 be funded by the Development Charge Reserve – Fire (3.24140), as outlined in Table-1 in report PUR2023-012 Multi-Year Procurement for Supply and Delivery of Fire Rescue Pumpers and Tankers;

That subject to receipt of the required document, that the Mayor and clerk be authorized to execute the agreement; and

That the Department be authorized to issue a purchase order.

Background:

At the Council Meeting of April 19, 2022, Council adopted the following resolution:

That Report FIRE2022-001, Fire Service Fleet, be received; and

That the procurement process begin immediately for the acquisition of one (1) replacement pumper truck and one (1) replacement tanker truck.

Request for Proposal 2023-02-CP for the Supply and Delivery of New Fire Rescue Pumper Trucks – Multi Year Contract was released for advertising in accordance with the Purchasing Policy. The funds were allocated in the following approved capital budgets for the replacement of one unit each; the 2020 capital budget (932200203) allocated \$600,000 (this pumper is partially funded by development charges) and the 2023 capital budget (932230201) allocated \$824,000.

Request for Proposal 2023-03-CP Supply and Delivery of New Fire Rescue Tanker Trucks – Multi-Year Contract was released for advertising in accordance with the purchasing policy. The approved 2021 capital budget (932210101) allocated \$625,000 for one unit and the 2023 capital budget (932230202) allocated \$1,751,000 for two units (one of these units is partially funded by development charges).

The request for proposal closed on March 16, 2023 with the following results:

As per the Purchasing Policy procurement awards that exceed the budget by more than \$10,000 are considered irregular and must be approved by Council.

An evaluation committee carefully evaluated and scored each proposal by consensus, based on the criteria described within the request for proposals. Each proposal was rated on the response to the technical specifications that meet the departments requirement for the pumper and tanker trucks; company profile and experience; warranty and training details, value added features information and pricing.

Submissions were checked for compliancy to the proposal requirements and for mathematical errors.

Carl Thibault Emergency Vehicles Inc. was found to be the highest scoring proponent. The vendor is known to the City.

Rationale:

Staff recommend that Request for Proposal 2023-02-CP Supply and Delivery of New Fire Rescue Pumper Trucks –Multi Year Contract be awarded to Camions Carl Thibault inc. and that Request for Proposal 2023-03-CP Supply and Delivery of New Fire Rescue Tanker Trucks –Multi Year Contract be award to Camions Carl Thibault inc.

Staff also recommends that Council authorize the option to renew each of the contracts after the initial term for four (4) additional one (1) year periods, based upon annual Council budget approval, mutual agreement of the pricing and successful completion of the initial term and each term thereafter.
