Background:

On February 6, 2023 the City of Kawartha Lakes received email correspondence from the County of Huron (Appendix B) indicating that at a meeting held on February 1, 2023, their Council passed the following motion:

Moved by Councillor G. Finch, Seconded by Councillor M. Anderson

That the Council of the County of Huron approve the report by CAO Meighan Wark dated February 1, 2023 titled Report to Council: Cannabis Act Information as presented;

And Further That the Council of the County of Huron advocate for improvements to the Cannabis Act and current legislative framework for cannabis in Canada by sending the report titled Report for Council: Cannabis Act Information, including the correspondence found in the appendices, to the Western Ontario Warden's Caucus (WOWC) for discussion and consideration;

And Further That The Council of the County of Huron approve forwarding Call to Action Letters to the following for support:

- Federation of Canadian Municipalities (FCM)
- All Municipalities in Ontario
- Ministry of Agriculture, Food and Rural Affairs (OMAFRA)
- Premier of Ontario
- Provincial Minister of the Environment, Conservation and Parks

On Monday, March 13, 2023, the City of Kawartha Lakes received email correspondence from the Western Ontario Wardens' Caucus (Appendix A) indicating that the following resolution was passed at their meeting held on March 10, 2023:

That the Huron County resolution, re "Call to Action - Cannabis Act Review, be supported." – Carried.

At the April 13, 2023 meeting of the Agricultural Development Advisory Committee the following resolution was passed:

Moved by A. VanVught, Seconded by M. Murphy-Ward

That the correspondence received from the County of Huron and from the Western Ontario Wardens' Caucus be received; and

That the Agricultural Development Advisory Committee recommends support for the requests for review of the Cannabis Act as indicated within the County of Huron report "Call to Action – Cannabis Act Review".

This report addresses those requests for support in review of the Cannabis Act.

Rationale:

During Committee discussion there was support for review of the Cannabis Act related to concerns noted by the County of Huron including:

- Serious odour impacts on local communities and residents from cannabis production facilities, most often from properties used for "The Production of Cannabis for Own Medical Purposes by a Designated Person".
- Lack of adequate odour controls to manage impacts on surrounding homes, public facilities and the community at large.
- Requiring confirmation of compliance with local municipal by-laws prior to approval by Health Canada of license application.
- Implementation of a system of minimum setbacks between cannabis production facilities and sensitive odour receptors, including homes and public facilities.
- Further notice and enhanced consultation with municipal governments when drafting and implementing legislation and regulations related to cannabis producer.
