- The Bethany Bahá'í Centre of Learning (BBCL) is a non-profit educational facility operated under the guidance of the National Spiritual Assembly of the Bahá'ís of Canada, which took possession of this 12 acre property on April 30, 2020.

- BBCL representatives inquired about the legitimacy of an existing sign affiliated with the previous land owner, located within the City's road allowance.

- The Chief Building Official informed us that the Public Works Department were agreeable to allow the sign to remain on their road allowance provided we enter into an encroachment license agreement.

- After commissioning a survey, an application was made to Realty Services.

- On January 23, 2023 we were informed that the Land Management Team could not approve our request as they stated: "only regulatory signs should be located on the road allowance"

- No other objection was noted

- The BBCL is requesting the approval of a sign encroachment agreement for an existing sign located within the road allowance at Ski Hill Road and Bethany Hills Road.
