## **Background:**

At the Council Meeting of July 11, 2017, Council adopted the following resolution:

#### CR2017-627

RESOLVED THAT Report ED2017-013, Downtown Lindsay and Oak Street Heritage Conservation District Plans, be received;

**THAT** the recommendation of Heritage Victoria to adopt the Heritage Conservation District Plans for the Oak Street neighbourhood in Fenelon Falls and for Downtown Lindsay Neighbourhood under Part V, Section 41.1(6) of the Ontario Heritage Act (R.S.O. 1990, c.O.18), be approved; **THAT** staff be authorized to proceed with the process to designate the districts under Part V of the Ontario Heritage Act, including preparation and circulation of a Notice of Intention to Designate, and preparation of designating by-laws;

**THAT** the designating by-laws be presented to Council for its consideration after the notification process has been completed; and **THAT** two new municipal heritage committee member categories be introduced on Heritage Victoria to provide the opportunity for one representative member from the Lindsay BIA and one from the Oak Street neighbourhood to provide advice to Council on matters of heritage conservation in the City of Kawartha Lakes.

RESOLVED THAT Report ED2017-015, Downtown Lindsay and Oak Street Heritage Conservation District Designation Bylaws, be received:

**THAT** consideration of the draft By-law, being A By-law to Designate the Downtown Lindsay area, as identified in the Downtown Lindsay Heritage Conservation District Plan, in accordance with Section 41 of the Ontario Heritage Act, be forwarded to the October 24, 2017 Regular Council Meeting;

**THAT** the draft By-law, being A By-law to Designate the Oak Street neighbourhood in Fenelon Falls, as identified in the Oak Street Heritage Conservation District Plan, in accordance with Section 41 of the Ontario Heritage Act, be approved; and

**THAT** the necessary By-law be brought forward for adoption.

This report addresses resolution CR2017-758 and the first four items from resolution CR2017-627.

#### Rationale:

Council has completed all of the requirements for the creation of a Heritage Conservation District under Part V of the Ontario Heritage Act and approved Heritage Victoria's recommendation that Downtown Lindsay become a Heritage Conservation District based upon its distinctive character and significant historical associations.

#### Other Alternatives Considered:

Other alternatives are not recommended based upon Council approval to proceed with the creation and adoption of a by-law to designate Downtown Lindsay as a Heritage Conservation District.
