We have questions about how WSP was engaged by CKL. What are the terms of that contract? We would like to know what long term implications or commitments CKL will have fulfilling that contract. We also want to know if WSP and their recommendations have anything to do with the 5G towers we now have within our county. If not, who is, and who authorized them and is accountable for maintenance and damages / health effects that could be occurring now and in the future?

We have several issues with the new ByLaw plan itself including, but not limited to, the curb of expansion of agricultural industry on one hand and the liberal allowance of marijuana production on the other.

We also don't see enough allowance for residential expansion around our smaller towns and villages. We'd like to see more acre lots and estate homes on our rural roads. This enhances the value of our area and would make use of sustainable building and lifestyles were the by laws to reflect that. The suburbs we currently see being thrown up in the urban areas do not reflect sustainability or green practices. We also have concerns about the fact that the WSP itself has been given over to determine our laws. They are not a local company and we do not believe they serve our interests foremost.
