I own 1011 Portage Road and 1017 Portage Road. We have been informed these properties will have Heritage Designation. We are against the Heritage designation. We would like to present our view why it should not be. We feel as owners we should have a choice. We feel it can be done at a later time if needed but we do not feel it should be done now. We have done no changes to the outside of the building. We have no plans to tear down the building. Putting a Heritage title will interfere with our insurance and it may cause it to be cancelled since it is more expensive. I have only one insurance who is willing to insure it. If it is not insure then I cannot have a mortgage on the property. This Heritage title will cause me to lose the property since I will not be able to afford it without a mortgage. Three previous owners have already gone bankrupt owning it. We are from Toronto and have invested in Kawartha Lakes. We had to sell other properties which all have gone in value much more than our Kirkfield property. We have no regrets since we love Kirkfield. We love to maintain the property so the town can be proud. When the bank owned it due the foreclosure, it was abandoned. We have two plagues on the property for Sir William Mackenzie. We have had visitors who have been very rude demanding a tour. Often they feel it belongs to the city and they can come on the property as they wish. If it is made Heritage, it will increase the traffic whether it is planned or not. We come to Kirkfield from Toronto for the peace and quiet and it will make the situation worse for us.
