4.7 KLMHC2023-054

Objection to the Proposed Heritage Designation of 1011 Portage Road, Geographic Township of Eldon

E. Turner provided an overview of the objection received in relation to 1011 Portage Road. A. Hart noted that he remained highly supportive of the designation because of the national significance of Sir William Mackenzie. S. McCormack asked if staff had spoken to the owners regarding the issues raised in the objection and E. Turner confirmed she had had multiple interactions with the owners. W. Peel asked what we know about the owners and their intentions for the property. E. Turner confirmed that they were not intending on developing the property at the present time and but that they had indicated they might want to build a new house on the property. I. McKechnie asked if plans for a new house would come to the Committee for review and A. Hart confirmed that they would. Councillor Ashmore asked for clarification regarding the current status of the property and if it should just be listed and E. Turner explained that the property currently was listed and the provincial amendments through Bill 23 were forcing the City to designate the property. She also reminded the Committee that, if the property was not designated, it would have no heritage protection and the City would not be able to relist it. I. McKechnie noted that this was one of the few major historic structures in downtown Kirkfield from the late nineteenth century and was important to the village. J. Pitcher asked how it would work if the owners wanted to sever part of the lot and A. Hart noted that a severance would still be possible as long as the house and other major features were preserved. Councillor Ashmore stated that he did not think the property should be designated against the owner's wishes. W. Peel stated that he believed Council should proceed with the designation.

Turner noted that that would be one of the things the subcommittee should address. A. Hart added that there have already been discussions in community and there is support. Councillor Ashmore asked where the district boundaries would be and E. Turner replied that the subcommittee would need to figure that out as part of the wider project planning.

The restaurant had formerly served as Cragg's Box Lunch and served lunches for the railway. It is one of only a few railway related buildings in that area still standing. He suggested that the building be listed for its historical and contextual value. He noted he had written an article in the Advocate about it and had a number of photos.

A. Hart suggested that the matter be tabled until the next meeting to give a chance for the material to be circulated and reviewed by the Committee. I. McKechnie agreed that he would forward the information to E. Turner to circulate.
