Background

In the development and approval of the annual capital budget, the Terms of Reference of the Victoria Manor Committee of Management describe the Committee's role as follows:

Advice to Council

The Committee may make recommendations to Council on the following matters, for which Council retains the decision-making role:

1. The annual capital and operating budget;

In 2022 and previous years, the Ministry of Health and Long Term Care (MOHLTC) provided a Structural Compliance per diem to eligible long term care homes. This program has now evolved and is known as the Comprehensive Minor Capital Funding. Included in this annual funding are funds for repairs, maintenance and upgrades to the home; funds for Infection Control Personnel; and funds for falls prevention. For Victoria Manor, the repairs and maintenance portion funding was allocated to fund the annual capital budget. For the purposes of the proposed 2023 Capital Budget, \$118,000 will be allocated within the existing funding structure.

The requirements for capital projects in the home remain and are recommended to continue to maintain the home.

Rationale

The recommended 2024 capital projects, totaling \$118,000, are shown in Table 1 below.
