A summary of my feedback, and that of other concerned CKL property owners, on the final Rural Zoning By-law consolidation proposal. This 380-page proposal was published in July 2023 and has not been assessed sufficiently in the opinion of property owners to which it will apply in the years to come.

Angel Godsoe requested a two month extension to the September 1 deadline and was granted 2 weeks by Council which unfairly curtailed efforts to engage more CKL property owners in their review so this complex document. Given that it has taken 4 years for City staff and the WSP consulting company to prepare this final report, it is not unreasonable for CKL property owners to have a least 2 months to study it.

A handful of concerned constituents object to this September 15 deadline decision but, given the time limit imposed, have volunteered to review the document and provide feedback. This deputation is intended to provide our feedback in front of Council and all other concerned constituents who plan attend the next Council meeting.
