A By-law to Amend The Township of Mariposa Zoning By-law No. 94-07 To Rezone Land within the City of Kawartha Lakes

File D06-2023-024, Report PLAN2023-062 respecting Part of Lot 6, Concession 11, geographic Township of Mariposa, now City of Kawrtha Lakes, being 332 County Road 46.

Recitals

- 1. Section 34 of the Planning Act, R.S.O. 1990, c.P.13 authorizes Council to determine the appropriate zone categories and provisions assigned to land.
- 2. The Director of Development Services as delegated by Council has required the subject lands be rezoned in order to sever a farmhouse deemed surplus to the needs of an agricultural operation as a result of the consolidation of agricultural land as a condition of provisional consent application D03-2020-015.
- Council has received an application to amend the categories and provisions relating to a specific parcel of land in accordance with the provisional consent conditions.
- 4. A public meeting to solicit public input has been held.
- 5. Council deems it appropriate to rezone the property.

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2023- .

Section 1.00: Zoning Details

- 1.01 **Property Affected:** The Property affected by this by-law is described as Part of Lot 6, Concession 11, geographic Township of Mariposa, identified as 332 County road 46, now City of Kawartha Lakes.
- 1.02 Schedule Amendment: Schedule 'A' to By-law No. 94-07 of the Township of Mariposa is further amended to change the zone category on:
 - (a) A portion of the property from 'Agricultural (A1) Zone' to 'Rural Residential Type One (RR1) Zone' as shown on Schedule 'A' attached to this By-law;
 - (b) A portion of the property from the 'Agricultural (A1) Zone' to 'Environmental Protection' (EP) Zone, as shown on Schedule 'A' attached to this By-law;
 - (c) The balance of the lands zoned 'Agricultural (A1) Zone' to 'Agricultural Exception Forty Two (A1-42) Zone' as shown on Schedule 'A' attached to this By-law.
