#### 4.6 KLMHC2023-070

Amendment to the Heritage Delegated Authority By-law

E. Turner provided an overview of the proposed amendments to the Heritage Delegated Authority By-law which would delegate the approval of all commercial signage applications to staff to provide consistent service delivery between the Downtown Lindsay Heritage Conservation District and individually designated commercial properties in other communities in Kawartha Lakes. Councillor Ashmore asked how the amendments would work in practice with larger applications such as the application relation to the Academy Theatre that the Committee reviewed in September. E. Turner explained that large applications, such as those which required Council approval, that were part of bigger alteration applications, or were associated with certain types of Planning and Building applications, would still be received and reviewed by the Committee.

#### 4.7 KLMHC2023-071

Objection to the Proposed Heritage Designation of 11 John Street, Town of Lindsay

The Committee decided that it would discuss the objections received to the proposed heritage designation of the four local schools together (items 4.7, 4.8, 4.9 and 4.10) as they all contained similar issues and concerns, but would make separate motions in relation to each staff report and property.

E. Turner provided an overview of the designations, discussion with the school board and the objections received. A. Hart noted that, if the schools were not designated, the City would lose significant control over their reuse if they were

closed in future which looked likely. J. Hartman asked if there were plans to build new schools to replace them. E. Turner indicated that there were no concrete plans by the school board at this time but schools sites had been designated in a number of new subdivisions around Lindsay which may be used in future. Councillor Ashmore noted that it did not necessarily make sense to close existing schools. J. Hartman also asked for an explanation of FCI and how that factored into the cost to rebuild versus renovate which E. Turner explained. J. Hartman also asked if designating a school meant that the City could prevent it from closing or only how it was used in future. E. Turner explained that the designation of the properties would give the City, through Council and the Committee, additional tools to shape the future use and development of these sites if and when the schools closed. I. McKechnie asked about Jack Callaghan Public School, which was also listed, and if there were discussions around designating it as well. E. Turner indicated that it likely would not fulfill the criteria for designation, as updated by Bill 23. I. McKechnie also asked about the conversations with the Board and if it was the Board as a whole that objected or just certain staff. E. Turner indicated that the internal discussions at the Board were not known as the Board has chosen to not engage with City staff who have reached out to discuss the designations and objections. W. Peel asked for clarification on AODA and how accessibility could be integrated into heritage buildings as this was a concern raised by the Board. E. Turner noted that designation did not limit compliance with AODA as demonstrated by heritage buildings owned by the City. W. Peel also suggested that the schools would be good candidates for adaptive reuse projects, such as residential projects. Councillor Ashmore said that the designations should be supported because the schools are important public buildings.
