My goal is to encourage City Council and the City of Kawartha Lakes to place the known and immediate risks to our Energy Security as top priority over the uncertainty of the alleged and unproven threats of Climate Change from burning fossil fuels. To place restrictions on the building of gas-fueled energy plants is the kind of policy that undermines our Energy Security as well as the productivity and prosperity of our citizens and businesses.
