By-Law 2023-___

A By-law to Provide for the Erection of Yield Signs in the City of Kawartha Lakes at Various T-Intersection in the Rural Subdivision Known as Victoria Place

Recitals

- 1. Council adopted Resolution Number CR2023-587 approving of the traffic control in this area.
- The Municipal Act, 2001, S.O.2001, c.25 authorizes municipal councils to pass by-laws respecting traffic on highways under their jurisdiction, in conjunction with the provisions and requirements of the Highway Traffic Act, R.S.O. 1990, c.H.8.
- 3. This by-law enacts the approved traffic control.

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2023-__.

Section 1.00: Definitions and Interpretation

- 1.01 **Definitions**: In this by-law,
 - "City", "City of Kawartha Lakes" or "Kawartha Lakes" means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;
 - "City Clerk" means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;
 - "Council" or "City Council" means the municipal council for the City;
 - "Director of Engineering and Corporate Assets" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.
 - "Director of Public Works" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

1.02 Interpretation Rules:

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.
- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.
- (c) Except as otherwise provided in section 1.01, the words and terms used in this by-law have the same meaning as the words and terms used in the Highway Traffic Act, R.S.O. 1990, c.H.8.

- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability:** If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

Section 2.00: Regulate Traffic

- 2.01 **Yield Control**: Yield sign shall be erected on Country Club Circle on the approach which terminates at Country Club Circle.
- 2.02 **Yield Control**: Yield sign shall be erected on Country Club Circle on the approach which terminates at Old Surrey Lane.
- 2.03 **Yield Control**: Yield sign shall be erected on Port Colony Road on the west approach which terminates at Old Surrey Lane.
- 2.04 **Yield Control**: Yield sign shall be erected on Port Colony Road on the east approach which terminates at Old Surrey Lane.
- 2.05 **Yield Control**: Yield sign shall be erected on The Captains Corners on the west approach which terminates at Old Surrey Lane.
- 2.06 **Yield Control**: Yield sign shall be erected on The Captains Corners on the north approach which terminates at Old Surrey Lane.
- 2.07 **Yield Control**: Yield sign shall be erected on Forest Harbour Trail on the south approach which terminates at Old Surrey Lane.
- 2.08 **Yield Control**: Yield sign shall be erected on Forest Harbour Trail on the north approach which terminates at Old Surrey Lane.
- 2.09 **Yield Control**: Yield sign shall be erected on Sail Vista Drive on the north approach which terminates at Old Surrey Lane.
- 2.10 **Yield Control**: Yield sign shall be erected on Sail Vista Drive on the south approach which terminates at Old Surrey Lane.
- 2.11 **Yield Control**: Yield sign shall be erected on Tall Pine Court on the approach which terminates at Old Surrey Lane.
- 2.12 **Yield Control**: Yield sign shall be erected on White Birch Way on the approach which terminates at Old Surrey Lane.
- 2.13 **Yield Control**: Yield sign shall be erected on White Birch Way on the approach which terminates at Country Club Circle.

Section 3.00: Enforcement, Offence and Penalties

3.01 **Enforcement:** This by-law may be enforced by every police officer.

- 3.02 **Obstruction:** No person shall hinder or obstruct, or attempt to hinder or obstruct, any person exercising a power or performing a duty under this bylaw.
- 3.02 **Offence and Penalty:** It is an offence for a person to contravene any provision of this by-law, and every person who contravenes this by-law is guilty of an offence and, on conviction, is liable to a fine in accordance with the provisions of the Provincial Offences Act, R.S.O. 1990, Chapter P.33, as amended and the Highway Traffic Act, R.S.O. 1990, c.H.8 and any other applicable penalty.

Section 4.00: Administration and Effective Date

- 4.01 Administration of the By-law: The Director of Engineering and Corporate Assets is responsible for the administration of this by-law. The Director of Public Works is responsible for the installation and maintenance of the signs and road painting authorized by this by-law.
- 4.02 **Effective Date:** This By-law shall come into force on the date it is finally passed, and after properly worded signs have been erected.
