The coming surge in Lindsay's population will mean much more traffic congestion on local streets, as well as greatly increased use of trails. It will not make sense to continue allowing ATVs to use city streets. Further the Victoria Rail Trail between Logie St/Dobson St and Golden Mile Rd is predominantly used by people walking, jogging or cycling, and should be closed to ATV use, much like the Heritage Trail at the north end of Lindsay. ATVs (and dirt bikes) are causing deterioration in the trail surface. CKL needs to plan for more trail space for the future trail walkers and cyclists.
