We confirm your above-noted request was reviewed by the Land Management Committee at their meeting on June 11, 2018. Unfortunately, the Committee members could not approve your request as they felt that the entirety of the road allowance width would be required if the City were to construct a proper turnaround.

The Committee is supportive of entering into a License Agreement to allow the well to remain in its current location within the road allowance.
