A By-Law to Deem Part of a Plan of Subdivision, Previously Registered for Lands within Kawartha Lakes, Not to be a Registered Plan of Subdivision in Accordance With the Planning Act PIN Number 63273-0396 (LT), Lot 4, Plan 240, Con 7 PT Lot 12, RP 57R3440 Part 14 and PIN Number 63273-0570 (LT), Lot 5 PT Lot 6, Plan 240, PT Shore Road, 57R9977 Parts 1 to 3, Geographic Township of Laxton, now City of Kawartha Lakes

#### Recitals:

- 1.
