

# **The Corporation of the City of Kawartha Lakes**

## **By-Law 2024-**

### **A By-Law to Authorize the Execution of an Agreement between The Corporation of the City of Kawartha Lakes and His Majesty the King in Right of Ontario as Represented by the Solicitor General for the Commissioner to Assume Policing Responsibility Under Section 22(2)2 of the Community Safety and Policing Act, 2019 S.O. 2019, c.1, Sched. 1**

#### **Recitals**

1. The Municipality has expressed its intent to have the Commissioner assume policing responsibility for the City of Kawartha Lakes, excluding the Town of Lindsay and the former Township of Ops.
2. Resolution CR2024-225 was adopted by Council at the Regular Council Meeting of April 20 2024 to provide authority for the Mayor and the City Clerk to execute the proposed Assumption of Policing Responsibility Agreement.
3. This By-Law shall provide authority for the Mayor and the City Clerk to execute the final version of the Agreement, as attached as Appendix A.

**Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2024-      .**

#### **Section 1.00: Definitions and Interpretation**

##### **1.01 Definitions:** In this by-law,

**“Chief Administrative Officer (CAO)”** means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

**“City”, “City of Kawartha Lakes” or “Kawartha Lakes”** means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;

**"City Clerk"** means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;

**“Council” or “City Council”** means the municipal council for the City;

##### **1.02 Interpretation Rules:**

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.
- (b) The words “include” and “including” are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.

- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability:** If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

## **Section 2.00: Authorization**

- 2.01 **Authorization:** The Mayor and the City Clerk are hereby authorized and directed to execute an Agreement between The Corporation of the City of Kawartha Lakes and His Majesty the King in Right of Ontario as Represented by the Solicitor General for the Commissioner to Assume Policing Responsibility Under Section 22(2)2 of the Community Safety and Policing Act, 2019 S.O. 2019, c.1, Sched. 1 and affix the City of Kawartha Lakes' corporate seal.

## **Section 3.00: Administration and Effective Date**

- 3.01 **Administration of the By-law:** The Chief Administrative Officer is responsible for the administration of this by-law.
- 3.02 **Effective Date:** This By-law shall come into force on the date it is finally passed.

By-law read a first, second and third time, and finally passed, this 21<sup>st</sup> day of May, 2024.
