Background:

The Economic Development Division has developed a Film + Television Production Office. This work was based on previous Council direction:

Furthermore, Section 6.09 of By-Law 2016-009; A By-Law to Provide Authority for the Execution of Certain Documents and Affix the Corporate Seal on Behalf of the City of Kawartha Lakes:

6.09 A contract or agreement between levels of government, requires a Council Report recommendation adopted by Council that approves the contract or agreement and authorizes the Mayor and City Clerk to sign.

requires all recommended contracts or agreements between levels of government be adopted by Council and authorizes the Mayor and City Clerk to sign on their behalf. The Clerk's Department has identified that Ontario Creates is a Provincial Agency of the Government of Ontario, and is subject to Freedom of Information and Protection of Privacy Act, the same as the Province, and not the Municipal Freedom of Information

and Protection of Privacy Act. Therefore, Council needs to approve the agreement and directs the Mayor and City Clerk to sign on its behalf.

This report addresses that direction.

Rationale:

In 2022, Council approved joining the Province's Ontario Green Screen Program as a non-voting member. The opportunity to include environmental film production industry standards in the foundational elements of the City's Film + Television Production Office is advanced through the City's participation in this program. The policies, programs, supports and collaborative opportunities are a valuable resource to the City and will help to further the implementation of key municipal strategies and programs. In addition to the development of the Film office, this initiative aligns with other City strategies.

As identified in the 2019 Healthy Environment Plan, the City has identified that it has a key role to play in reducing climate risks and addressing GHG emissions by:

- Influencing change, through the local regulatory frameworks such as assessments and approval processes, the use of surcharges and rebates, integrating the strategies into existing plans and policies and the enforcement of adaptive policies that address community climate impacts;
- Implementing the provincial Planning Act, and through adopting land use policies that support climate mitigation and adaptation principles and result in long lasting impacts to reducing emissions while creating safe and sustainable places to live;
- Actively demonstrating leadership through action as a municipality to ensure climate change considerations are integrated into service delivery and asset management; and
- Playing a strong role in communicating with and providing opportunities for residents and businesses to take part in collective action.

Participation on the Ontario Green Screen (OGS) Council ensures access to programs and partnerships that support the integration of initiatives from the Healthy Environment Plan are integrated into the new Film + Television Production Office. Staff will have access to the latest environmental programs and supports which should help the office to integrate strategic actions and long range planning tools to mitigate the environmental impact of film production in the municipality and help reduce Green House Gas emissions related to this industry.

Partnering with this program has also provided additional opportunities for advertising and marketing Kawartha Lakes as a municipality that aligns with the growing interest by production companies to work where there are environmentally sound practices and processes, reinforcing the fact that Kawartha Lakes is a great place to bring a production.

As stated in the 2022-2025 Ontario Green Screen Strategic plan, the OGS Program, facilitated by Ontario Creates, "is only possible through a strong collaboration between Ontario Creates and industry and municipal partners. Collectively, the three sectors have a shared responsibility to embrace and improve sustainable production practices. While advancing these initiatives through their own organizations, industry and municipalities recognize the importance of collaboration in accelerating this important work. Film and television production takes place across the Province and OGS partners represent many diverse aspects of the film and television production sector. The success of OGS cannot be accomplished without the input, investment and innovation of these industry champions representing producers, cast and crew (above and below the line), studios, equipment suppliers, post-production and municipalities."

In its first two years, OGS found its footing with an initial 18 members who guided its direction. In 2022, an additional 12 partners from all segments of the industry, culminated in 30 official partners for 2022-23. 2023-24 continued the focus of developing resources, partnerships and recommendations for 2024 and beyond.

The voting structure has also changed so that all members have one vote with the fee structure reflecting more the scope of practice: national, provincial or local deciding the membership fee.

The OGS Partner Agreement is attached as Appendix A.

Other Alternatives Considered:

Alternatively, Council can receive the report for information but not endorse participation in the program through the following Resolution.

That Council receive the report for information but no action is taken at this time.

This is not recommended by Staff.

Alignment to Strategic Priorities:

Participation in the Ontario Green Screen Program aligns with all four strategic priorities within the 2024-2027 Kawartha Lakes Strategic Plan but most notably Priority 1: Healthy Environment by increasing waste diversion and resource recovery

- Expand recycling programs to increase diversion rate
- Implement a Source Separated Organics program
- Enhance public education and partnerships to promote recycling and diversion

The development and execution of green Film + Television production initiatives will also support the activities of Council and staff in cultivating an Exceptional Quality of Life; A Vibrant and Growing Economy and demonstrate Good Government practices.

Financial/Operation Impacts:

The Ontario Green Screen Program membership cost of \$2,500 is included in the 2024 Economic Development operating budget.

Collaboration with other Departments such as Public Works, Engineering and Corporate Assets, and Building and Property Divisions will be encouraged to assist in strategic implementation the Ontario Green Screen activities where deemed appropriate.
