System Process Description

Raw Source

The water supply for the DWS comes from two (2) groundwater wells that are designated as non-GUDI (groundwater under direct influence).

Treatment

The treatment system consists of the following:

- two (2) nitrate removal systems, with softener
- sodium hypochlorite disinfection system
- clearwell/contact storage tank
- two (2) supply pumps and on-line monitoring equipment


The Mariposa Estates Drinking Water System is operating on average under half the rated capacity.

Raw Water Flows

The Raw Water flows are regulated under the Permit to Take Water. 2023 Raw Flow Data was submitted to the Ministry electronically under permit #8473-AZUGSX. A copy of the confirmation is included in Appendix A. The Permit to Take Water compliance criteria is in litres per minute (L/min) but for the purposes of this report the flow rate is reported in litres per second (L/sec) based on industry standard for flow monitoring recording.


Total Monthly Flows (m³/d)

Max Allowable PTTW - Well #1




Monthly Rated Flows (L/s)

Max Allowable Rate - PTTW - Well #1



Monthly Rated Flows (L/s) Max Allowable Rate – PTTW – Well #2






Monthly Rated Flows

Note: For continuous monitors 8760 is used as the number of samples. Spikes recorded by on-line instrumentation were a result of air bubbles and various maintenance/calibration activities. All spikes are reviewed for compliance with O. Reg. 170/03, did not indicate a true exceedance. A true exceedance would be documented within this report.

Inorganic Parameters

These parameters are tested as a requirement under O. Reg. 170/03. Sodium and Fluoride are required to be tested every five years. Nitrate and Nitrite are tested quarterly and the metals are tested every three years as required under O. Reg. 170/03. In the event any of the parameters exceed half of the maximum allowable concentration the parameter is required to be sampled quarterly.
