Background:

The Kawartha Lakes Airport Advisory Committee was established in January of 2019 to replace the former Kawartha Lakes Airport Board to provide advice and recommendations to the Airport Manager and Council on the operation and strategic development of the Kawartha Lakes Municipal Airport.

The updated Terms of Reference (2019) for the Kawartha Lakes Airport Advisory Committee stipulates that an annual report be provided to Council by the end of Q1 each calendar year and to present their upcoming work plan for the upcoming year.

Rationale:

In 2023 the Kawartha Lakes Airport Advisory Committee achievements were as follows:

- Fuel sales are down approximately 24,000 litres over the same period last year.
- There is an increase in people looking for hangars due to Buttonville closing. T Hangars are full. There are currently a few spots available for tiedowns.
- New events took place, including but not limited to, Cruise-In/Fly-In, The Trillium Aviators and The Transport Canada Helicopter Fly In.
- Work is underway to complete all outstanding capital projects.

In the upcoming year the Kawartha Lakes Airport Advisory Committee will continue with the following;

- Runway 03/21 upgrade/expansion (multi-year cash flow project)
- Runway 13/31 resurfacing (multi-year cash flow project)
- Runway 13/31 crack sealing, shouldering and similar interventions needed to hold the runway over until resurfacing in 2027
- Horizon hangar roof restore roof on the Horizon Hangar
- Airport terminal roof repairs to terminal roof due to leaks
- Hangar area surface pave grass area north of main apron and south of new hangars
- Hangar electrical services grading and electricity services for proposed 10 new hangars
