# A By-Law to Amend the Town of Lindsay Zoning By-Law No. 2000-75 to Rezone Land within the City of Kawartha Lakes

[File D06-2023-031 Report PLAN2024-038, respecting E/S Hamilton Street; 57R-5111 Part 1; Plan 137 Lots 51 to 57 and 64 to 66 and Part Robertson Closed; former Town of Lindsay, now City of Kawartha Lakes]

#### Recitals:

- 1. Section 34 of the Planning Act, R.S.O. 1990, c.P.13 authorizes Council to determine the appropriate zoning categories and provisions assigned to land.
- 2. Council has received an application to amend the categories and provisions relating to a specific parcel of land.
- 3. A public meeting to solicit public input has been held.
- 4. Council deems it appropriate to rezone the Property.

Accordingly, the Council of the Corporation of the City of Kawartha Lakes enacts By-law 2024-\_\_.

### **Section 1:00 Zoning Details**

- 1.01 **Property Affected**: The Property affected by this by-law is described E/S Hamilton Street; 57R-5111 Part 1; Plan 137 Lots 51 to 57 and 64 to 66 and Part Robertson Closed; former Town of Lindsay, now City of Kawartha Lakes
- 1.02 **Textual Amendment**: By-law No. 2000-75 of the Town of Lindsay is further amended by adding the following new section to Section 20.3 General Employment Special Exception Eleven (GE-S11) Zone:

#### 20.3.14 **GE-S11 Zone**

- a. Notwithstanding the permitted uses and zone requirements on lands zone GE, on land zoned GE-S11 a mini-storage warehouse is a permitted use.
- b. All other provisions of this By-law shall continue to apply.
- 1.03 **Schedule Amendment:** By-law No. 2000-75 of the Town of Lindsay is further amended to change the zone category:

a. From 'General Employment (GE) Zone' to 'General Employment Special Exception Eleven (GE-S11) Zone', as shown on Schedule 'A' attached to this by-law.
