# Recommendation(s):

That Report PUR2024-016, 2024-046-CQ Woodville and Fenelon Falls Standpipes Rehabilitation, be received;

**That** BGL Contractors Corp be selected for the award of the Request for Quotation (RFQ) **2024-046-CQ Woodville and Fenelon Falls Standpipe Rehabilitation** for the submitted price of \$1,346,600.00 (not including HST);

**That** Council authorize the award to OCWA for the Construction Management of the Standpipe Rehabilitation for the total amount of \$99,545.78 not including HST;

**That** the deficit of \$633,755.00 (including payable HST) be financed from the Water Infrastructure Reserve (1.32050);

**That** subject to receipt of the required documents, the Director of Engineering and Corporate Assets be authorized to execute the agreement to award; and

**That** the Engineering and Corporate Assets Department be authorized to issue a purchase order.

# **Background:**

Ontario Clean Water Agency (OCWA) maintains the responsibility for operations and maintenance of the Woodville and Fenelon Falls Water Treatment Plants (WTP) and Standpipes on behalf of the City. A standpipe is a ground-level potable water storage tank (shaped like a vertical pipe) and is connected to the water supply system. The extra height of the standpipe tank allows it to use gravity to maintain proper water pressure in the distribution system and ensures a continued supply of water during peak demand or firefighting and emergencies.

OCWA retained a consulting firm to carry out condition inspection and assessment of both interior and exterior of each tank and identified numerous needed repairs, including but not limited to:

- exterior concrete roof restoration,
- interior tank recoating, and
- miscellaneous repairs such as roof venting system upgrades, valve chamber piping enhancements, and crack repairs.

To be compliant with safety standards, the inspection report also recommended replacing or upgrading safety systems, including a new access ladder, fall arrest system, and handrails. Staff recommend making these repairs to the standpipes to ensure safe working conditions and maintain clean, reliable water for both communities as well as be compliant with Drinking Water Works Permit and License.

The Request for Quotation (RFQ) 2024-046-CQ Woodville and Fenelon Falls Standpipes Rehabilitation was issued in accordance with Purchasing policy. The RFQ was opened electronically on June 27, 2024, with the following results:

References were checked and found to be favorable

#### **Rationale:**

Staff recommend that BGL Contractors Corp be selected for the award of the Request for Quotation 2024-046-CQ Woodville and Fenelon Falls Standpipes Rehabilitation as the lowest compliant bidder. However, there is a budget deficit to award the contract

and complete the construction work. The supply-chain and labour market are still constrained which has contributed to higher prices. Additionally, there is a limited number of contractors that are qualified to undertake this type of specialized work. This limits the competitiveness within the potable water tank rehabilitation/coating work. For overall cost savings, the two (2) projects were combined, which will save the City any additional construction cost.

#### **Other Alternatives Considered:**

No alternative is being recommended as a competitive procurement process was issued and the lowest compliant bidder is being recommended.
