## A By-Law To Amend The Township of Emily Zoning By-Law 1996-30 To Rezone Land within The City of Kawartha Lakes

[File D06-2024-010, Reports PLAN2024-045, respecting 58 Shoreview Road; Part of Lot 20, Concession 12, in the Township of Emily]

#### Recitals:

- 1. Section 34 of the Planning Act authorizes Council to determine the appropriate zoning categories and provisions assigned to land.
- 2. Council has received an application to amend Section 7.3 with one site-specific, exception zone, which will apply to a specific parcel of land, to amend the zone provisions as outlined below.
- 3. A public meeting to solicit public input has been held.
- 4. Council deems it appropriate to rezone the Property.

Accordingly, the Council of the Corporation of the City of Kawartha Lakes enacts By-law 2022-\_\_.

## **Section 1:00 Zoning Details**

- 1.01 **Property Affected**: The Property affected by this by-law is described as Part of Lot 20, Concession 12, in the Township of Emily being 58 Shoreview Road.
- 1.02 **Textual Amendment**: By-law No. 1996-30 of the Township of Emily is further amended by adding the following new section to Section 7.3.\* Agricultural Exception X (A1-XX) Zone:
- 7.3.\* Agricultural Exception X (A1-XX) Zone

Notwithstanding the permitted uses and zone requirements of the A1 zone, land zoned A1-XX may only be used for the following uses:

a. Single Detached Dwelling

All other provisions of this By-law shall continue to apply.

1.02 **Schedule Amendment**: Schedule 'A' to By-law No. 1996-30 of the Township of Emily to be amended for the portion of the subject lands that contain wetlands from the "Agricultural (A-1) Zone" to the "Environmental Protection (EP) Zone", as shown on Schedule 'A' attached to this By-law.
