# What action are you hoping will result from your presentation/deputation? \*

We have not seen any map showing how the allocation is to be distributed for the needed 38 hectares of additional land. Hopefully, the Committee will refer the matter back to staff with the instruction to allocate the residential growth component more equitably to ensure that there is competition in the market place and that a monopoly situation is not assigned to one land developer in the Fenelon Falls Urban Settlement Area. Further, that the lands owned by Black Bear Estates in the north west area of Fenelon Falls be assigned a residential allocation. Such an allocation would reflect the content of the originally adopted Secondary Plan for the Fenelon Falls Urban Settlement Boundary (OPA 15). When OPA 15 was adopted by City Council the subject property was designated for Development. The Province, in reviewing the adopted Official Plan, instructed the City to reduce the total amount of land designated for development. Without any advanced notice and without any background report on which lands should be removed, that we are aware of, Council deleted the designation on the subject lands. Absolutely no opportunity was given to Mr.Webster to make representation to Council.
