

AGREEMENT OF OWNERS

WHEREAS it is found necessary that a Ditch should be constructed, or otherwise improved, under the provisions of the Ditches and Watercourses Act, for the draining of the following lands and roads:-

AND the Township road between Concessions Ten and Eleven controlled by the Municipal Council thereof.

THEREFORE we the Owners within the meaning of the said Act of the said lands and Wm. M. Graham, the Reeve of the said Municipality of Ops, on behalf of the Council thereof do agree each with the other as follows:--
