The EDO-Agriculture reported that the Steering Committee continues to work through development plans for a pilot aggregation and distribution project. The funding contract with OMAFA was Novated to Kawartha Lakes due to the dissolution of the Peterborough & the Kawartha Lakes Economic Development. The project coordinator and consultants will continue to work with the project.

6.4 Proposed Tree Preservation By-law - Private Lands - Update

The City Solicitor reports that a draft of the Tree Protection By-law will be posted to the JumpIn site shortly.

- The threats of Tariffs have impacted sales with 25% on lawn and garden, and possibly others to come on larger equipment
- Orders from the US for the seed businesses have been lost due to Tariff concerns - Triticale

- Members Parker, Van Vught and Skrabec volunteered for shifts at the East Central Farm Show booth
